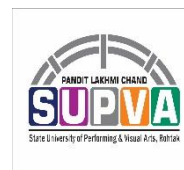

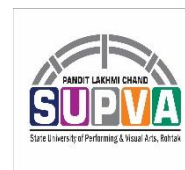

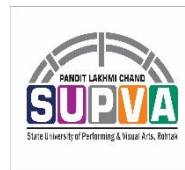

General Terms & Conditions and Instructions

1. The number of posts may be increased or decreased or withdrawn completely without assigning any reason.
2. Self-attested legible PDF copies of all relevant documents must be appended to the online application.
3. Abbreviations: - Gen stands for General Category, SC for Scheduled Castes, BC for Backward Classes, EWS for Economically Weaker Section, ESM for Ex-Servicemen/ DESM (Dependent of Ex-Servicemen) and PWD for Person with Disability.
4. The reservation has been given as per State Govt. Reservation Policy. However, the reservation of posts is subject to change as per Govt. of Haryana Reservation Policy/norms that come into force from time to time. Change, if any, will be notified through the University Website.
5. Candidates who are already in the Service of Govt. /Semi Govt./ Govt. Aided Bodies/ Universities must apply through proper channel. They may send an advance copy to avoid delay but application must also be received through proper channel or they should produce "No Objection Certificate" at the time of interview, failing which they will be ineligible and will not be allowed to appear in the interview.
6. Candidates are advised to visit the University website regularly for any Update/Test/New Instructions/Scrutiny/ Selection Process/ Corrigendum including the interview schedule.
7. All columns must be filled in the application form. No column should be left blank. Instead it should be marked 'NA' wherever not applicable.

8. The benefit of reservation will be given only to those SC/BCA/BCB/PWD/EWS/ESM/ESP candidates who are domiciles of Haryana State. These candidates are required to upload SC/BCA/BCB/ESM/PWD/EWS/ESM/ESP certificate duly issued by the competent Authority of Haryana and shall produce the original at the time of the Interview and joining if selected. Only those PWD candidates would be eligible for reservation who suffer 40% or more relevant disability.
9. The dependent sons/daughters of ESM who fulfill all conditions of qualifications, age etc. prescribed for posts will be considered on merit for the posts reserved for ESM, if suitable ESM candidates are not available. ESM/DESM candidates of Haryana claiming benefit will have to produce the fresh Eligibility Certificate from the concerned Zila Sainik Board to the effect that his/her father has not availed the benefit of re-employment in any Government Service, Public Sector Undertaking, including Para-Military Forces, in view of State Government instructions prevailing at the time of interview. Mere dependent certificate will not be entertained. ESM candidates should also produce at the time of interview attested photocopy of identity card issued by the concerned Zila Sainik Board.
10. Backward Class Block (A & B) candidates claiming benefit of reservation have to upload a certificate issued by the competent authority of Haryana dated not before six months of the last date of receipt of applications mentioning therein that he/she is not covered under the criteria of creamy layer as per State Govt. instructions issued vide letter No. 1170-SW(1)-95 dated 07.06.1995 & No. 213-SE(1) -2010 dated 31.08.2010 , No. 22/22/2004 #GS-111 dated 14.06.2016, No. 1282-SW(1) dated 28.02.2018 and No. 512-SW(1) 2021 dated 01.12.2021 as per Annexure titled “Backward Class Certificate (BLOCK ‘A’ or ‘B’).
11. The eligibility of every candidate will be determined on the basis of qualifications acquired and communicated to the office by him/her up to the last date fixed for submission of online applications. No certificate /document will be accepted after the last date.
12. The experience of service/working only in Govt./Semi Govt./Govt. Aided Bodies/ Universities or as given in the advertisement will be considered. Further the experience will be considered only when acquired after obtaining the minimum prescribed qualifications.
13. No TA/DA will be paid for attending the test/interview etc.
14. Haryana Govt. rules will be applicable for determination of age of the applicant as on the closing date for submission of application.

15. Age relaxation to the candidates belonging to reserved categories such as SC, BC, ESM, EWS and PWD shall be given as per the State Govt./University rules.
16. Candidates applying for a post must ensure that they fulfil all the eligibility conditions on the last date of application. If, it is found on verification at any time before or after the written examination or interview or appointment that any candidate does not fulfil any of the eligibility conditions or it is found that the information furnished is false or incorrect, his/her candidature/appointment will be cancelled/terminated and it may invite legal action also against him/her.
17. In case, any candidate wants to apply for more than one post, separate Online Application Form must be submitted for each post alongwith requisite fee and relevant documents.
18. After online submission of application and payment of application fee, the applicant must take a printout of the application form, attach all necessary documents having bearing on selection, append his/her signature on all the pages of the application form including attached documents, and send the same to **The Asstt. Registrar (Establishment), Pandit Lakhmi Chand State University of Performing & Visual Arts, Rohtak** so as to reach the aforesaid Office **within seven days from closing date for online submission of application form** failing which the applicant/ candidate shall be considered outrightly ineligible for shortlisting as well as Interview. Incomplete application(s) received without the documents and prescribed fee or received after the last date of receipt of applications are liable to be rejected.
19. Candidates are advised to retain a hard copy of the application and fee receipt for further verification during the recruitment process, if required.
20. Wheresoever the result of educational qualifications has been shown by the concerned institute/examination body in CGPA/GPA and not in score percentage, such a candidate is directed to upload/bring with him self-grade conversion formula to transcribe the CGPA/GPA into percentage.
21. Candidates with foreign degree are required to submit copy of AIU Equivalence Certificate without which application will be rejected straightaway without assigning any reason.
22. The qualifications, research and academic performance and selection criteria for Non-Teaching posts, wherever applicable, are available in **Annexure-II**.

23. The benefit of Experience as per rules/guidelines will be given only to those candidates who possess and produce the experience certificate from the Government/Semi-Government/PSUs/Universities/ Govt. Aided/ other recognized institutions.
24. Keeping in view the number of applications for a particular post, University may hold a written test to shortlist the candidates. The test will be of one hour containing multiple choice questions commensurate with the qualifications of the post. The details thereof will be uploaded on the website, if the need for the test arise.
25. Candidates are required to have a valid personal active Email ID as all the information regarding the recruitment process will be sent to their registered Email ID throughout the process as an additional service by the University. In case, a candidate does not have a valid personal Email ID, the candidate should create a new Email ID before applying online and must maintain the Email account throughout the selection process.
26. Candidates must give a valid Mobile Number, as all the SMSs during the process will be sent on that Mobile Number.
27. Candidates are advised not to change their Mobile Number/email ID mentioned at the time of Registration.
28. Tie will be resolved on the basis of age. Candidate higher in age shall be given preference.
29. For 01 post, top 20 candidates in the merit list will be called for interaction. If the number of posts exceeds 20, then 10 additional candidates will be called for each additional post. This will be applicable only to those posts for which merit list will be prepared on the basis of computer skill test/written test.
30. Dispute, if any, is subject to District Courts, Rohtak/ Punjab & Haryana High Court, Chandigarh.

ADDITIONAL INSTRUCTIONS FOR FILLING ONLINE APPLICATION FORM:-

1. The candidate must fill all information carefully as it will not be possible to change/update the same at the later stage.
2. Information provided during registration phase cannot be changed after registration. Information in other sections cannot be changed after payment of the application fees.
3. Separate application form must be filled for each post.

4. The candidate must upload self-certified copies of all relevant documents which has a bearing on eligibility and selection criteria. For example, all academic qualifications, Ph.D./JRF details, experience details and information submitted for claim of API score etc.
5. File size of photograph, signature and other documents must be less than 250 KB. All uploaded files must be in JPEG format and must be of good quality and clearly legible.

DOCUMENTS TO BE ENCLOSED WITH APPLICATION FORM

1. Copies of certificates of all essential qualifications.
2. Copies of experience certificate(s).
3. Copy of Haryana Domicile Certificate in case of BC/SC/EWS/ESM/DESM/PWD issued by the competent authority.
4. Passport size photograph duly signed by the candidate.

ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

Candidates are warned that they should not furnish any particulars that are false, tempered/fabricated or should not suppress any material information while filling up the application form. At the time of written examination/interview, if a candidate is (or has been) found guilty of:

- (a) Using unfair means during the examinations or
- (b) Impersonation or procuring impersonation or
- (c) Misbehaving in the examination hall or taking away the question booklet or any part thereof from the examination hall or
- (d) Resorting to any irregular or improper means in connection with his/her candidature for selection or
- (e) Obtaining support for his/her candidature by any unfair means, such a candidate may, in addition to rendering himself/herself liable to criminal prosecution, shall be liable to be:
 - (i) disqualified from the examination/interview for which he/she is a candidate; and/ or

- (ii) debarred either permanently or for a specific period from any examination or recruitment conducted by the University.

NOTE:
