5. Date and Place of Examination/Test:

The information qua date and place of examination/test shall be uploaded on the official website of District Courts, Karnal i.e. **https://karnal.dcourts.gov.in/notice-category/recruitments/** in due course. However, no separate letter/information in this regard shall be issued to the candidates. The Candidates are required to bring their proof of identity at the time of written test/interview, failing which, he or she will not be allowed for test.
